#### General discussion about Schools pick up/drop off locations:

• Pick up's and drop offs, public parking and signage's are moving smoothly on HFES. City is working on adding a round-about on basswood and Wann rd.

## Department Update and committee feedback on registration forms/Dates/ Route timeline:

• Addition of Text/Email notification fields in the form, where users can opt out if they do not wish to receive delay/cancellation notifications.

- A special request column has been added to registration forms. All special requests are to be emailed to student transportation email address.
- Registration forms timeline from May 15 till June 20 and by July 26 route finalization.
- Dept. of Edu is still working on online registration forms for 2022-23 School year.
- Dept. of Edu will advertise on social media regarding the registration process.
- Will send the registration forms to all committee members by email for further review and feedback with a deadline.
- We are working with the City to implement the Token transit app pass for the start of the 2022/23 school year. Paper passes would be provided for those who do not have a cell phone.

Suggestion: Committee want to invite the rural school communities to be a part of the School busing committee.

### School bus safety/ Taskforce and pilot projects

- School bus safety task force suggest the following safety measures with Stoparm/infraction cameras, extended stop arms, exterior perimeter visibility systems and automatic emergency braking.
- Transport Canada is collaborating with BC gov, City of Sudbury to carry out seat belt pilot projects to assess the operational considerations associated with the use of three-point seatbelts on six school buses.
- Even though Covid has impacted the task force and pilot projects, their preconsultations have already taken place and publications of the proposal is intended for mid-2022.
- Committee members were agreed to have the extended arm to be very effective in Yukon.
- Education to reach out to Standard to get their thoughts on the Taskforce and recommendations and determine current arm length on buses.
- Dept. of Edu confirmed that all the Standard buses operating currently are adhere to the present Transport Canada safety regulations.
- Dept. of Edu have provided 4 dash cams for strengthening the school bus safety in standard bus.
- Dept. of Edu has added that Transport Canada will most likely to have this safety measures to be added to the new buses.
- Transport Canada will continues its efforts to advance the research and assessment of the safety measures.
